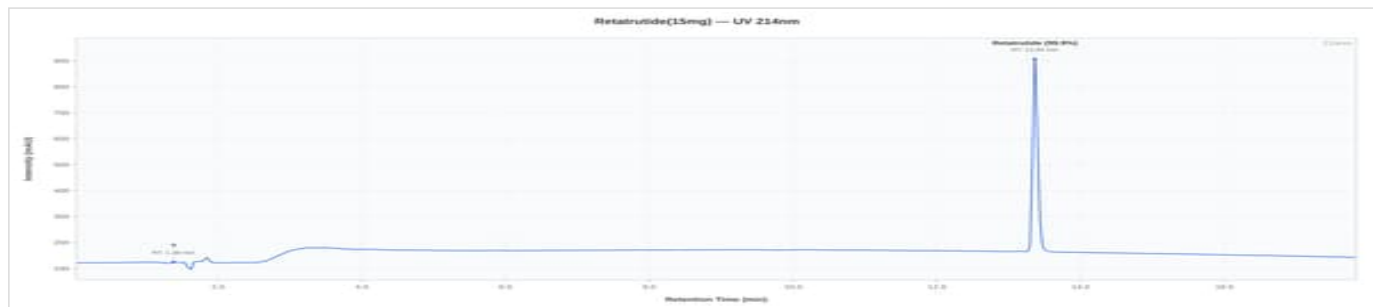

- Date Tested: 08/25/2026. Methods: Purity, Identity & Quantitation (HPLC).
- The sample was confirmed to be Retatrutide by HPLC. Identification by chromatographic retention time comparison with a reference standard.
- Endotoxin tested per USP <85> kinetic chromogenic method. Acceptance criteria per client specification.
- Peptide purity determined by RP-HPLC area normalization at 214 nm. Value represents the percentage of the target peptide relative to all peptide-related peaks. Non-peptide process-related impurities, if detected, are excluded from the calculation.
